STATE CONVENTION IN AUSTIN VERY “BATty”

The Texas Council PD CA Convention was held in Austin at the Radisson Hotel on October 7-9th. Opening ceremony included a touching, heart felt memorial service by Ed Travis from San Antonio. Those who were remembered at the ceremony were Raymond Harkins and Jeffrey Harrison, along with former PDCA member Wade Hopkins.

Rick Palmer presented several of the PCEP modules including *The Basics of Insurance*. We hear about insurance at a lot of our meetings, but this one included some information I had not heard before. Another PCEP module was on *How to Paint Yourself a Profit*. Everyone wants to make a profit and Rick presented this program which focused on using Break-Even Analysis as a method of increasing profits.

The Texas Construction Association was there to let everyone know what is going on in the legislature. Hopefully the “pay if paid” legislation that was in line for approval last year will make it to a vote this session. It looks promising. Other issues of concern being worked on include Prohibiting Indemnification Clauses, Right to Sue Public Entities, Workers Compensation Reform, and School Finance and Tax Reform.

Fred Wilshusen of Thomas, Feldman, & Wilshusen, LLP in Dallas presented a program similar to the one our own Paulo Flores presented at our September meeting. This one included Bid Exclusions and Negotiating Contract Scope.

Another very interesting seminar was on employee health insurance. This covered the reasons for increases in health insurance premiums and ways that employers are cutting back costs by utilizing the new Flexible Spending Accounts, Health Reimbursement Accounts, and Health Savings Accounts. The speaker explained the differences between each of these and how they can benefit both the employee and employer.

The fun stuff included Thursday night dinner at the Moonshine Grill (sponsored by Anco Insurance), a wonderful evening spent at the Texas State History Museum (sponsored by 3M Company and Sherwin-Williams Co.), PPG/Monarch sponsored the hospitality suite that was open throughout the convention, and ICI/Dulux Paint Centers sponsored our Saturday night Town Lake Cruise where we all experienced the flight of the bats that are famous in Austin.

A very special thanks to all the sponsors, those vendors who had table tops, and everyone who attended. The convention next year will be held in Houston, and they are promising a great time will be had by all.
